2 Safety

2.1 Intended use

The product is a residential low-voltage Li-ion battery system with an integrated BMS, designed for solplanet solar hybrid inverters. It supports on-grid, off-grid, and backup modes with compatible solplanet inverters. Suitable for indoor and outdoor use within a temperature range of -18°C to 58°C.

The battery system must only be used as stationary equipment.

Modifications to the product are prohibited without written approval from Solplanet. Solplanet will not be held liable for any damage caused by such illegal changes.

The product is not suitable for supplying life-sustaining medical devices. Please ensure that no personal injury would lead due to the power outage of the battery system.

The product must only be used in countries for which it is approved by Solplanet and the grid operator.

Use the product only in accordance with the information provided in this guide, the user manual and with the locally applicable standards and directives. Any other application may cause personal injury or damage to property.

The type label must be permanently attached to the product and must be in a legible condition.

This document does not replace any regional, state, provincial, federal or national laws, regulations or standards that apply to the installation, electrical safety and use of the product.

♠ DANGER

When the battery system is connected to the inverter and the ON/OFF switch is ON, the batteries generate DC voltage, energizing the DC cable and live components.

- Do not touch non-insulated parts or cable ends.
- Do not touch the DC conductors.
- Do not touch any live components of the product.
- Do not open the product.
- All work on the product must only be carried out by qualified personnel who have read and fully understood all safety information contained in this document and the user manual.
- Disconnect the product from all voltage and energy sources and ensure it cannot be reconnected before working on the product.
- Wear suitable personal protective equipment, in accordance with local regulations, for all work on the product.



WARNING

The battery is an electrochemical device and poses a risk of explosion under extreme conditions. Maintain a safe distance if such a situation arises.



Beware of danger to children!

The battery must be inaccessible to children.



Beware: Flammable!

Keep the battery system away from open flames or ignition sources.

Do not dispose of the product together with the household waste. Dispose the product in accordance with local disposal regulations for electronic waste applicable in the country of installation.

The battery can be recycled by a professional recycling organization, please refer to the relevant local regulations.






1-5 batteries connected with one set of output cables (120 A max.)







